DESCRIPTION:

On April 3, 2011, Toledo Baby Child & Family Expo is celebrating dance with a new addition to our expo! "So You Think You Can...Waddle?" theme will be judged by the Toledo Baby panel! The contest winners will be awarded the coveted 2011 Toledo Baby Expo award. We will have four categories:

- 3) Best Routine
- 4) Most Creative

DANCE CONTEST RULES:

- Entry Fee: FREE.
- Applications may be submitted beginning March 1, 2011.
- Judging will be a general panel and will be judged by our selected area supporters.
- Winners will be announced Sunday, April 3rd after the competition ends.
